FACE TO FACE LEARNING -

Criteria of exemption and requirements for approval.

Dear parent,

"GREETINGS FROM NIMS-SHARJAH"

It is my pleasure to inform you that all our staff are Covid-19 Vaccinated and all the required health and safety protocols are in place in the school to welcome 100% students for the face to face learning.

Please be informed that the regular attendance of your ward is mandatory. As we switch over to the full face to face mode of learning from 31st October 2021, for those who are absent from the school, their attendance will be considered only based on the criteria mentioned in the attached file (please check the attached file for the criteria of exemption).

In all such cases, the mentioned supporting documents need be attached along with the application letter. Approvals will be subject to verification of details / supporting documents.

Kindly note that unauthorized absence will lead to initiating disciplinary actions as per the guidance from SPEA.

Categories exempted from attendance education in schools

Exemptions	Requirements
1. Students with active high-risk chronic disease. Also, students who are immunocompromised because of active chronic disease or students on long-term immunosuppressive medication.	MOHAP-attested detailed medical report by a MOHAP-licensed Physician, who is either a Consultant or Specialist in his/her medical discipline. The medical report shall be addressed/presented to the Student's School Clinic recommending distant learning for the student for a specific period of time, after describing the student's health condition and demonstrating evidence towards the risk of contracting COVID-19 disease if the sick student is physically attending school.
2. Healthy students living with patient/s with high-risk chronic disease, who have medical exemption from receiving the COVID-19 vaccine.	MOHAP-attested detailed medical report by a MOHAP-licensed Physician, who is either a Consultant or Specialist in his/her medical discipline. The medical report should be addressed/presented to the Student's School Clinic recommending distant learning for the student after describing the health condition of the household patient/s and that they are exempted from receiving the COVID-19 vaccine. The medical report should also be demonstrating evidence towards the risk of contracting COVID-19 disease by the household patient if the student is physically attending school.
3. Students who are held up in their home country (i.e. outside the UAE) due to COVID-19 related reasons.	Official document/s attested by the UAE Embassy/Consulate in the student's home country demonstrating evidence towards the reason behind their inability to travel back to the UAE. This document/s shall be addressed/presented to the concerned school administration for decision.
4. Isolated/quarantined students, during the isolation/quarantine period.	The COVID-19 Committee's Decision upon completion of the case investigation process undertaken by the health authority in Sharjah.
